HFLA-SA does not charge interest; however, as outlined below, we require timely repayment of all borrowed funds. Each HFLA-SA Loan is secured by a Borrower's Promissory Note and further, by Cosigner Agreements from well-qualified individuals, with each party guaranteeing entire repayment. This practice allows HFLA-SA to safeguard and perpetuate funds, ensuring money remains available for further borrowing.

1. APPLICANT/BORROWER:

- a. MUST be Jewish AND a permanent resident of the San Antonio Service Area for at least six (6) months
- b. Must be enrolled in a qualified Post High-School Academic program
- c. Must submit required documents, including copies of Driver's License, Social Security and proof of enrollment (e.g. Transcript, Tuition Statement, etc.).
- d. Must be 18 years old (or Parent / Guardian of otherwise eligible Student)
- e. Must obtain two (2) well-qualified Cosigners for \$2,000 or more, one (1) if less than \$2,000 Loan
